Seasonal Flu Vaccine

Allen Occupational Health will begin distributing flu vaccine to area companies starting the first of October. The CDC recommends that people get their flu vaccine as soon as vaccine becomes available. While we have not yet received our supply, we expect to have it any day, so now is the time to schedule your company's vaccine clinic.

A couple of changes will take place this year to ensure regulatory compliance.

1. Payment for flu vaccines will be received from companies only.
2. Personal health insurance will not be filed, and personal checks/cash will not be accepted.
3. If a company employee is covered by Medicare Part B, the employee will need to present his/her Medicare Part B card. We are obligated to file a claim to Medicare Part B if we provide a beneficiary with a flu vaccine since Allen Hospital is a Medicare provider, and flu vaccine is a covered service.
4. Any company requesting Allen Occupational Health to provide a flu vaccine in the clinic for their employee/s will be asked to call in advance to authorize the service/payment as with any other medical service we provide.
5. Employees who are minors will require a parent/guardian to accompany them to sign a release to obtain a flu vaccine.
